The meeting was held at the NRC headquarters in Rockville, Maryland, and due to the classified nature of the information to be discussed, was closed to public observation. A meeting announcement was issued on August 31, 2000. A list of attendees is enclosed. The licensee gave a general discussion of the physical layout for the ISFSI, and then described specific physical security and safeguards details. Topics discussed included clear areas, isolation zones, intrusion detection systems, security force composition and activities, access control measures, alarm and monitoring stations, and communications arrangements.
