SUBJECT: 10/25/00 PUBLIC MEETING SUMMARY - INDIAN POINT UNIT 2  
ENGINEERING STATUS

On October 25, 2000, a public meeting was conducted between the Nuclear Regulatory Commission (NRC) and Con Edison to discuss the status of engineering at Indian Point Unit 2. The meeting was conducted at the NRC Region I office in King of Prussia, Pennsylvania. During the meeting, the NRC questioned Con Edison on various aspects of engineering support, including a recent engineering self-assessment, an Auxiliary Feedwater Safety System Functional Assessment (SSFA), Utility Tunnel Material deficiencies, and system engineering initiatives. The NRC also questioned Con Edison on how they plan to apply the lessons learned from these efforts to future SSFAs and system health reviews. The meeting lasted for approximately 4.5 hours. At the conclusion of the meeting, Con Edison presented the NRC with a copy of the "Indian Point 2 2000 - 2004 Business Plan" (See Attachment 1). Attachment 2 contains a list of attendees at the meeting. Attachment 3 contains presentation materials used at the meeting.
