The purpose of this contract modification is to allot incremental funds to this contract in the amount of \$37,000. Accordingly, the contract is modified as follows:

1. In addition, \$37,000 in incremental funds are hereby allotted to this contract. As a result, Section B.3 is hereby replaced by the following language:

B.3 CONSIDERATION AND OBLIGATION--COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991)

(a) The total estimated cost to the Government for full performance of this contract is \$505,312 of which the sum of \$468,933 represents the estimated reimbursable costs, and of which \$36,379 represents the fixed fee.

(b) There shall be no adjustment in the amount of the Contractor's fixed fee by reason of differences between any estimate of cost for performance of the work under this contract and the actual cost for performance of that work.

(c) The amount currently obligated by the Government with respect to this contract is \$467,200 of which the sum of \$433,564.80 represents funds for the estimated reimbursable costs, and of which \$33,635.20 represents funds for the fixed fee.

(d) It is estimated that the amount currently allotted will cover performance through March 31, 2001.
