

The purpose of this modification is to provide incremental funding in the amount of \$95,000.00, thereby increasing the obligated amount of this contract. Accordingly, the contract is hereby modified as follows:

Under Section B.3 entitled 'CONSIDERATION AND OBLIGATION-TIME AND MATERIALS CONTRACT,' paragraph (e), the obligated amount is increased by \$95,000.00 from \$580,000.00 to \$675,000.00. Therefore, paragraphs (e) and (f) are deleted in their entirety and the following paragraphs are substituted in lieu thereof:

"(e) The amount currently obligated by the Government with respect to this contract is \$675,000.00."

"(f) It is anticipated that the obligated amount will cover performance through July 15, 2001."

A summary of obligations for this contract, from award through the date of this action, is provided below:
