

The purpose of this contract modification is to allot \$80,000 in incremental funds to this contract. Accordingly, the contract is modified as follows:

1. \$80,000 in incremental funds is hereby allotted to this contract. As a result, paragraphs (c), and (d) of Section B.4 of the contract are replaced with the following paragraphs for Section B.4:

"(c) The amount currently obligated by the Government with respect to this contract is \$630,812.67 of which the sum of \$580,795.60 represents funds for the estimated cost and 50,017.07 represents funds for the fixed fee.

(d) It is estimated that the amount currently allotted will cover performance through 3/31/01."
