

The purpose of this modification is to:

- (1) exercise the fourth option year of the subject contract in accordance with Paragraph I.5 - **Option to Extend the Term of the Contract**, at the fixed unit prices reflected under Paragraph B.7 - **Supplies or Services and Prices/Costs**;

Note: By virtue of electronic e-mail correspondence, which is hereby incorporated by reference and made a part hereof this contract modification, from Paul Sforza to Brenda DuBose dated November 7, 2000, KPMG hereby waives its right to receipt of a preliminary notice as reflected under Paragraph I.5 of the subject contract.

- (2) revise Paragraph B.8 - **Consideration and Obligation** to provide funding in the amount of \$7,680.00. As a result of exercising Option Year 4, the ceiling and obligated amount of the subject contract is increased from \$238,588 to \$246,268.00;
- (3) revise Paragraph F.2 - **Duration of Contract Period** from November 11, 2000 to November 11, 2001. (Note: This is the final option year to be exercised under the subject contract.); and
- (4) revise Paragraph H.1 - **Key Personnel**, to revise the name of the Project Manager.

Accordingly, the following changes are hereby made:

2. Under Paragraph B.8 - **Consideration and Obligation**, the first sentence of Subparagraphs (a) and (b) are hereby deleted in their entirety and substituted in lieu thereof the following:

"B.8 CONSIDERATION AND OBLIGATION

- (a) The total estimated amount of this contract is \$246,268.00.
- (c) The amount presently obligated with respect to this contract is \$246,268.00."

2. Under Paragraph F.2 - **Duration of Contract Period**, is hereby deleted in its entirety and substituted in lieu thereof the following:

"F.2 DURATION OF CONTRACT PERIOD

The ordering period for this contract shall commence on November 12, 1996 and will expire on November 11, 2001."

3. Under Paragraph H.1 - **Key Personnel**, Subparagraph (a) is hereby deleted in its entirety and substituted in lieu thereof the following:

"H.1 KEY PERSONNEL

- (a) The following individuals are considered to be essential to the successful performance of the work hereunder:

The contractor agrees that personnel may not be removed from the contract work or replaced without compliance with paragraphs (b) and (c) of this section."
