WITHDRAWAL OF MOTION FOR HEARING AND RIGHT TO INTERVENE

The Utility Workers Union of America, AFL-CIO, Local 1-2, ("Union") through its undersigned consultant, respectfully withdraws its request for a hearing and the right to intervene in the above proceeding. In explanation of this withdrawal, the Union states the following:

1. Subsequent to the Union's filing of both its Motion for Hearing and Right to Intervene and the Union's Response to the Applicants Answer dated July 31, 2000 with the Nuclear Regulatory Commission ("NRC"), Union representatives met with the Power Authority of the State of New York ("NYPA"), Entergy Nuclear Indian Point 3 ("ENIP3"), the proposed owner of IP3, and Entergy Nuclear Operations, Inc. ("ENO"), the proposed operator of IP3. Effective communications were established between the workforce and prospective employer/operator and safety issues of concern to the Union were discussed.
2. Based on the above discussions, the Union believes that both the proposed owner, and the proposed operator, of IP3 are committed to address the safety concerns of the Union regarding the operations of the IP3 facility. These discussions have also made



it apparent that management would be committed to workers' safety and open communications at IP3 such that any risk of radiological injury to the Union's members operating that plant and potential risk of collateral injury to the surrounding communities would be reduced.

Wherefore, for the reasons set forth herein, the Union respectfully withdraws its request that a hearing be established and that the Union be afforded the right to intervene in this proceeding.


