

Regarding Vermont Yankee's Generic Letter 96-05 Program**

Reference (a) provided additional information related to Vermont Yankee's (VY) Generic Letter 96-05 program. In Reference (a), VY committed to implement the applicable results of the Motor Operated Valve (MOV) Joint Owners Group (JOG) Phases 2 and 3 effort. In Reference (a), VY also indicated that any exceptions to the JOG Phase 2 and 3 results would be supported by plant specific data and documented as part of VY's MOV program. Based on subsequent discussions with Nuclear Regulatory Commission (NRC) staff, this letter is provided to commit to reviewing the exceptions, to the applicable JOG Phase 2 and 3 results, in accordance with VY's program for managing regulatory commitments. Managing regulatory commitments in this manner is endorsed by Reference (b).
