This proceeding concerns applications that together seek the Commission's authorization to transfer the ownership interest in, and operating/maintenance responsibility for (1) the Indian Point Nuclear Generating Unit No. 3 from the Power Authority of the State of New York (PASNY) to Entergy

Nuclear Indian Point 3, LLC, and Entergy Nuclear Operations, Inc. (ENO), respectively; and (2) the James A. FitzPatrick Nuclear Power Plant from PASNY to Entergy Nuclear Indian Point 3, LLC, and ENO, respectively. The notices of consideration of these transfer requests and opportunity for hearing were published in the Federal Register on June 28, 2000. See 65 Fed. Reg. 39,953 (2000); 65 Fed. Reg. 39,954 (2000).
