Subject: Report Required by Environmental Protection Plan

Dear Sir:

The Crystal River Unit 3 (CR-3) Environmental Protection Plan (EPP), Appendix B of the CR-3 Operating License, establishes reporting requirements related to environmental conditions. Section 4.1, "Significant Environmental Events," requires that reports to other Federal, State or local agencies shall be copied to the Nuclear Regulatory Commission (NRC).

The National Marine Fisheries Service (NMFS), NRC, and the Crystal River Energy Complex completed an Endangered Species Act Section 7 formal consultation process in 1999. The Biological Opinion issued by the NMFS include terms and conditions which require that a written report be submitted to NMFS for sea turtle mortality occurring at the Crystal River Energy Complex.

A report of a sea turtle mortality (see attached) has been made to the National Marine Fisheries Service.

Subject: Sea Turtle Report

Dear Sir:

The National Marine Fisheries Service (NMFS), Nuclear Regulatory Commission, and the Crystal River Energy Complex completed an Endangered Species Act Section 7 formal consultation process in 1999. The Biological Opinion issued by the NMFS include terms and conditions which require that a written report be submitted for sea turtle injury or mortality occurring at the Crystal River Energy Complex.

On November 6, 2000, a sea turtle carcass was discovered on a subsurface area of a Crystal River Unit 3 intake bar rack. As the bar rack was being lifted up onto the intake structure deck for cleaning, the carcass floated free and partial skeletal remains were recovered. The circumstances associated with the death of the turtle were discussed with the Florida Fish and Wildlife Conservation Commission (FWC). In the absence of any obvious injury or disease, Florida Power Corporation has concluded that the mortality was causally-related.
