**SUBJECT: ACKNOWLEDGMENT OF RESPONSE TO NOTICE OF VIOLATION AND
EXERCISE OF ENFORCEMENT DISCRETION, BROWNS FERRY NUCLEAR
PLANT (NRC OFFICE OF INVESTIGATIONS REPORT NO. 2-1999-028 AND
INSPECTION REPORT NOS. 50-259/00-03, 50-260/00-03, 50-296/00-03)**

Dear Mr. Scalice:

By letter dated November 22, 2000, Mr. T. E. Abney, Manager, Licensing and Industry Affairs, Browns Ferry Nuclear Plant, provided Tennessee Valley Authority's (TVA) response to our Notice of Violation (Notice) and Exercise of Enforcement Discretion, issued on October 27, 2000. The violation involved a former TVA employee who deliberately failed to perform measuring and test equipment nonconformance evaluations in accordance with site procedures, and was characterized at Severity Level III.

We have reviewed TVA's response and have concluded that it satisfies the provisions of 10 CFR 2.201. TVA's response provided clarifying information regarding your review of the circumstances involving this issue, and how the details of your review were communicated with the NRC. Based on our review, we have concluded that TVA's response addressed our concerns, and no additional corrective actions appear warranted. In that our characterization of the violation at Severity Level III with no proposed civil penalty has remained unchanged, no further response regarding this matter is required.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room (PDR) or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS).
