This letter is to inform you of changes in the U.S. Nuclear Regulatory Commission (NRC) staff assigned to various licensing responsibilities for the South Texas Project, Units 1 and 2, (STP). Since July 3, 2000, we have assigned an additional staff to support the timely review of your risk-informed request for exemptions from the special treatment requirements of NRC regulations. Effective December 4, 2000, Mr. Mohan Thadani, Senior Project Manager, will assume the responsibilities for routine STP licensing interactions, replacing Mr. Tae (T.J.) Kim. Mr. John A. Nakoski, Senior Project Manager, will continue to be the primary contact for matters related to the risk-informed exemption requests from the special treatment requirements. I believe the current arrangement of having dual project managers on STP has worked well, and will continue to allow Mr. Nakoski to focus on coordinating the effort for the review of the risk-informed exemptions that STP Nuclear Operating Company is seeking.
