The purpose of this modification is to extend the date for expending funds currently obligated under this Cooperative Agreement from "June 30, 2001" to "September 30, 2001." Modification No. 3 states that funds obligated under this Agreement, in the amount of \$340,000.00, will cover cost for work performed through June 30, 2001. However, due to several on-campus research projects lasting through the university's academic year (2000-2001), the Government and ORISE agree that those research projects will not be completed in their entirety until September 30, 2001; the expiration date of this Cooperative Agreement. In addition, ORISE agreed not to initiate any additional work using prior year funding (FY 2000) under this Agreement after September 30, 2000.

All other terms and conditions under this Cooperative Agreement remain unchanged.
