SUBJECT: MODIFICATION NO. 5 TO TASK ORDER NO. 3 ENTITLED, "SCDAP/RELAP5 THERMAL-HYDRAULIC CODE MAINTENANCE" UNDER CONTRACT NO. NRC-04-97-039

Dear Ms. Aguinaldo:

The purpose of this modification is to (1) incorporate a within-scope change to continue performance of code maintenance for the SCDAP/RELAP5 code in accordance with the attached statement of work and ISL's proposal dated November 17, 2000, both hereby incorporated; (2) increase the task order ceiling by \$184,027.00 from \$61,738.00 to \$245,765.00 to accommodate the change, (3) extend the period of performance, and (4) provide incremental funding in the amount of \$180,000.00.

Paragraph 2 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"The period of performance for Task Order No. 3 is March 24, 2000, through November 30, 2001. The total estimated cost for full performance of this task order is \$245,765.00, of which the amount of \$229,668.00 represents reimbursable costs and the amount of \$16,097.00 represents the fixed fee.

The amount currently obligated by the Government with respect to this task order is \$241,738.00, of which \$225,905.00 represents reimbursable costs and the amount of \$15,833.00 represents the fixed fee. It is estimated that the amount currently allotted will cover performance through November 1, 2001."

6.1 Transition
