Pursuant to the requirements of 10 CFR 50.54(p), the Union Electric Company furnishes four copies of Revision 30A of the Callaway Plant Physical Security Plan. Distribution of these documents is outlined on the attachment.

Revision 30A reflects a temporary change, moving the Health Physics RCA Access Point from door 31042 to 41011. Dual card readers were added to door 41011 along with appropriate electronic locks. No changes have been made concerning personnel who have access. This change was completed to allow a renovation of the old Health Physics Access floor of the Control Building. This modification will be removed after the renovation is complete.

Changes incorporated into this revision are consistent with 10CFR50.54 (p) and do not decrease the effectiveness of the Security Plan.
