

Staff Request 2:

Briefly discuss the specific procedure(s) for providing routine plant information to offsite officials. In light of the knowledge gained from the occurrence of the event, discuss whether any changes have been made or are planned to these procedures. If so, briefly describe the changes.

Response:

Providing routine plant information to offsite officials includes periodic Public Information Officer (PIO) meetings with state, county and municipal officials, as well as courtesy calls regarding key plant events. For example, a Con Edison spokesperson contacts offsite officials to inform them of key plant evolutions following a plant outage. Indian Point 2 senior managers periodically attend work sessions and planning meetings conducted by local offsite officials. Information regarding reportable events, or emergency classifications are released to offsite officials through Con Edison Corporate Media Relations, the Public Information Officer, or as applicable, through the Indian Point 2 Emergency Response Organization.

Since the February 15, 2000 event, management has increased its communications with offsite officials. For instance, shortly after the decision to remove the original steam generators, a plant vice president began a series of briefings with each of the local Town/Village Boards and Common Councils. As work on the steam generator replacement progressed, additional briefings were held. These meetings also provided an opportunity for Con Edison representatives to answer questions regarding the divestiture process as well as other Indian Point 2 issues. Additionally, the Emergency Response Organization conducts quarterly meetings with state and county Emergency Response officials. Finally, PIO meetings continue to be held bi-monthly with state, county and utility representatives in an on-going effort to inform offsite agencies on plant conditions and emergency preparedness.
