The U S. Nuclear Regulatory Commission (NRC) staff has completed its review of Homestake Mining Company's (HMC's) April 11, 2000, letter which presented the cost summary to complete reclamation of its Grants Mill site, and HMC's letter of June 8, 2000, requesting that the surety amount for reclamation of the Grants Mill site continue at \$24,000,000. The staff has also evaluated the financial data supporting HMC's parent company guarantee provided by its letters dated June 21, 2000 and July 26, 2000.

The staff has determined that the amount of the surety is adequate to complete site reclamation; site reclamation work accomplished in the last year is more than sufficient to account for inflation in the same period. The staff has also determined that HMC's parent company guarantee meets the NRC's financial assurance requirements and is acceptable. Therefore, no amendment to the license is required, and License Condition No. 28 will continue in effect, as approved by Amendment No. 26, dated May 21, 1997.
