TRAVEL INFORMATION

Meeting Location:

Clarion Hotel, 800 Commerce Street, Ft. Worth, Tx. A block of 25 rooms has been reserved for NRC attendees until January 10, 2001. Please confirm your own reservation prior to this date to ensure room availability by calling 817-332-6900.

Meeting Dates and Times:

January 22, 2001, 1:00 p.m. to January 24, 2001, 4:30 p.m.

Travel to Meeting Location:

Direct flights are available to DFW. From the airport to the Clarion, you can take a taxi or catch the "Airporter" bus. A taxi from DFW is available on the upper level and will cost about \$35.00. The Airporter bus departs DFW every half hour. Go to the PURPLE signs on the lower level labeled "scheduled transport" and watch for the large bus. It's a big bus like a Grayhound bus and has a big "T" on it. The cost is \$10.00 per person. If you have any problems catching the Airporter, call 817-334-0092. Rental cars may be used, however, due to the location of the hotel in the central business district of Fort Worth and the wide variety of restaurants, shopping, and entertainment within a short walking distance of the hotel, we recommend against rental cars. Travel time between DFW and the Clarion is approximately 30 minutes.

Weather:

January can be cold in north Texas with normal average temperatures in the 30s. However, it will likely be warmer than where you are coming from.
