Reference (1) Letter from R. M. Krich (ComEd) to U.S.NRC, " Request for Technical Specifications Change, Transition to General Electric Fuel," dated September 29, 2000

Commonwealth Edison (ComEd) Company in Reference 1, proposed changes to Appendix A, Technical Specifications (TS), of Facility Operating License Nos. NPF-11 and NPF-18. Specifically, we proposed revisions to support a change in fuel vendors from Siemens Power Corporation (SPC) to General Electric (GE) and a transition to the use of GE 14 fuel.

Based on recent contract negotiations with fuel vendors, ComEd has decided to retain SPC as its fuel vendor for LaSalle County Station. Therefore, we request the withdrawal of that portion applicable to LaSalle County Station of our submittal, identified in Reference 1.

We respectfully request the NRC to continue with their evaluations associated with Dresden Nuclear Power Station and Quad Cities Nuclear Power Station contained in Reference 1.



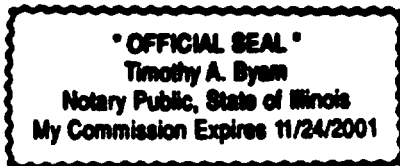
