

The purpose of this modification is to obligated FY'01 funds in the amount of \$200,000, thereby increasing the obligated amount, of the contract, from \$252,403 to \$452,000.

Accordingly, the contract is hereby modified as follows:

Under Section B - SUPPLIES OR SERVICES AND PRICES/COSTS, Paragraph B.4 - CONSIDERATION AND OBLIGATION, Subparagraph c is deleted in its entirety and substituted in lieu thereof the following:

- "(c) The amount obligated by the Government with respect to this contract is \$452,000, of which the sum of \$419,787.80 represents the estimated reimbursable costs, and of which \$32,212.20 represents the fixed fee.

A summary of obligations under this contract, from date of the award through this modification, is given below:
