Evaluations of BWR-4 and -6 Standard Tech Spec surveillances have been completed. Results confirm that for non-RG 1.105 parameters, no additional instrument uncertainty evaluations are warranted (nominal setpoints sufficient). For the RG 1.105 parameters, the evaluation has determined that less than 10% of the setpoint evaluations are required. This is an area for potential regulatory relaxation for BWRs.
