The purpose of this modification is to revise:

- (1) Subsection B.18 - Consideration and Obligation Work Orders, Paragraph (a) to increase the ceiling amount of Option Year 1 under the subject contract by \$189,150 from \$310,850 to \$500,000, to allow for additional local exchange services under Contract Line Item Number (CLIN) 001 of Subsection B.14 - Schedule of Prices/Costs. As a result, Subsection B.14 is hereby deleted in its entirety and substituted with the Attachment to this modification.

Note: As a result of the increase in services, the ceiling amount of the subject contract as reflected under the Base Year (\$405,000) and Option Year 1 (\$500,000) as revised, is \$905,000.

- (2) Subsection B.18 - Consideration and Obligation Work Orders, Paragraph (b) to increase the obligated amount of the subject contract by \$300,000.00 from \$485,000 to \$785,000.

Accordingly, the following changes are hereby made:

1. Under Subsection B.18 - Consideration and Obligation Work Orders, the first sentence of Paragraph (a) is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.18 CONSIDERATION AND OBLIGATION WORK ORDERS

- (a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$905,000."

2. Under Subsection B.18 - Consideration and Obligation Work Orders, the first sentence of Paragraph (b) is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.18 CONSIDERATION AND OBLIGATION WORK ORDERS

The amount presently obligated with respect to this contract is \$785,000"
