I am responding to your December 20, 2000, letter, requesting my assistance in expediting the processing of an exemption request to transport high-activity cesium sources in a non-Type B container. My staff is sensitive to your budgetary concerns. We have been working with your staff for 18 months, since we became aware that the package did not meet NRC requirements, to obtain the information that NRC needs to make a determination regarding your exemption request.

During an October 10, 2000, meeting with your staff, NRC identified the information missing from your exemption request. My staff also discussed ways for FEMA to provide the above information, which your staff committed to do expeditiously. On January 9, 2001, we received FEMA's revised application dated December 19, 2000. My staff will perform a review and will establish a schedule to complete our determination, including the preparation of an environmental assessment. I have asked my staff to work closely with your staff to bring the review to closure as soon as practicable.
