Scott Flanders is going to call this morning and discuss the Skull Valley project; 301/415-1172; Melanie Wong attended the call. She works out of Scott's office.
During Scott Flander's call above, I agreed to call the following: Roland McCook , Cedar City, Te-Moak, Wells Band, and Elko Band Council. The message is: We have sent letter on April 26, 2000, but no response; this is a follow-up to confirm if the tribes did not want to be consulting parties; do you want to participate, do you have any cultural resource concerns of interest to them; see below

September 26, 2000
Roland McCook , Ute Business Committee, U&O called Betsy Chapoose's office first, but she is not in until Thursday; Spoke with Gloria Mountain Lion , the office assistant, who did not find it in their log during a quick review; faxed her the April 26, 2000 letter.
Chairperson Geneal Anderson , Paiute Indian Tribe of Utah, Cedar City; she is out until tomorrow; Ms. Gayle Rollo , Tribal Administrator, took message and will bring it to her attention; see 10/3/2000
Elwood Mose , Chairman, Te-Moak, Elko; he is not in so spoke with Jennifer Saunders , Administrative Assistant; she has only been there a few months, so has not seen the letter; she suggested faxing 775/738-2345 the letter as Chairman Mose will be in tomorrow; see 9/29/2000
Nevada Penoli, Chairperson, Wells Band; 775/752-3045; began calling at 2:30pm and no answer at this number
Wilbur Woods , Chairman, Elko Band; left message at 775/738-9238; lady there suggested I contact David Gonzal Tribal Administrator (former Chairman), at 775/738-8889; called and left message there asking them to refer to fax the April 26 letter
September 29, 2000
Advised by Melanie Wong to add South Fork to my list to contact; don't think I should call them; go through the Tribe
Called Roland McCook at U&O, but they do not work on Friday; see below
Spoke with Charlotte Healey , Wells Band Administrator, proved to be a wealth of information; October 23 is election day for the Tribe; she also gave me the names of the people below
Charlotte Healey said that they would be interested in what happens at Skull Valley; liked the idea of meeting with them; suggested that meeting with the Te-Moak would be a good idea, when all the Bands are together; they meet the first Wednesday of the month; suggested to Charlotte that when they write back they should request a meeting
Faxed Charlotte Heally the April 26, 2000 letter; 775/752-2179 fax; she will pass it on to Nevada Penoli
Claudette Ramos Battle Mt. Band Administrator 775/635-8016 fax; don't think I should call her; go through the Tribe
Karen McDade sits in the Council member for South Fork; 775/744-4523 fax; don't think I should call her; go through the Tribe
Called Melanie Wong and advised on the above
In the course of talking to Ralph Pikyavit 435/759-2400, Cultural Resources Coordinator for the Kanosh Band, he expressed interest in being kept abreast of what we are doing at Skull Valley; I guess that means a Consulting Party

Helen Dave said that the Te-Moak Tribe was interested in the project and wanted to be kept abreast of things; also
that I should direct all correspondence to the Tribe
Helen Dave is interested in attending the meeting at Ibapah on Oct 23; all I could tell her was that it would be in the afternoon; called Melanie Wong and get details to relay to Helen; see 10/2/2000
October 3, 2000
Spoke with Melanie Wong and gave her details to relay to Helen Dave about the meeting in Ibapah; she is going to contact Helen about coming to Ibapah
Called Dave Allison about talking with Roland McCook at U&O about whether or not they want to be involved; h said he will see him this afternoon
Called Chairperson Geneal Anderson , Paiute Indian Tribe of Utah, Cedar City, or Ms. Gayle Rollo , Tribal Administrator; spoke with Gayle and she said to fax her the letter and she would bring it to Ms. Anderson's attentio today
<i>October 5, 2000</i>
While speaking with Gloria Benson about another matter, mentioned that I had been trying to get in touch with Chairperson Geneal Anderson about the Skull Valley project; Gloria said that I should fax it to her right now as swas expecting a call from Ms. Anderson shortly
Called Melanie Wong about the schedule so that a Paiute Tribal representative may attend one of the meetings in Ibapah or Wendover; left message; advised her of conversation with Gloria Benson and gave her the numbers for Gloria and Gayle Rollo ; Melanie also is going to call Dave Allison and inquire whether or not he asked Roland McCook about that Tribe's interest/involvement; see 10/13/2000
October 13, 2000
Conference call among the BIA folks involved with the EIS to go over the first set of comments
During the conference call, asked Dave Allison if he has had a chance to ask Chairman Roland McCook about the Ute's participation as a consulting party; he has not had a chance to approach him with that question, but had heard through the grapevine that they would defer; tried to call Chairman McCook but they are all off on Friday
Spoke with Chairperson Geneal Anderson from Paiute Indian Tribe of Utah and she and Gloria Benson have talka about this and they want to be involved in the sense they want to know what is going on; they have their next Triba Council meeting on November 1; Chairman Anderson said that it would not be too late to get on the agenda; contact the secretary Maureen Kietz to get on the agenda; when Chairman Anderson is not in, the contact is Gayle Rollo a then Gloria Benson
