	<b>Scott Flanders</b> is going to call this morning and discuss the Skull Valley project; 301/415-1172; <b>Melanie Wong</b> attended the call. She works out of Scott's office.
	During <b>Scott Flander's</b> call above, I agreed to call the following: <b>Roland McCook</b> , Cedar City, Te-Moak, Wells Band, and Elko Band Council. The message is: We have sent letter on April 26, 2000, but no response; this is a follow-up to confirm if the tribes did not want to be consulting parties; do you want to participate, do you have any cultural resource concerns of interest to them; see below
	Ohngo Gaudadeh Devia --- Ms. Margene Bullcreek; pg 6-22, line 9
	<i>September 26, 2000</i>
	<b>Roland McCook</b> , Ute Business Committee, U&O; called <b>Betsy Chappoose's</b> office first, but she is not in until Thursday; Spoke with <b>Gloria Mountain Lion</b> , the office assistant, who did not find it in their log during a quick review; faxed her the April 26, 2000 letter.
	<b>Chairperson Geneal Anderson</b> , Paiute Indian Tribe of Utah, Cedar City; she is out until tomorrow; <b>Ms. Gayle Rollo</b> , Tribal Administrator, took message and will bring it to her attention; see 10/3/2000
	<b>Elwood Mose</b> , Chairman, Te-Moak, Elko; he is not in so spoke with <b>Jennifer Saunders</b> , Administrative Assistant; she has only been there a few months, so has not seen the letter; she suggested faxing 775/738-2345 the letter as Chairman Mose will be in tomorrow; see 9/29/2000
	<b>Nevada Penoli</b> , Chairperson, Wells Band; 775/752-3045; began calling at 2:30pm and no answer at this number
	<b>Wilbur Woods</b> , Chairman, Elko Band; left message at 775/738-9238; lady there suggested I contact <b>David Gonzales</b> , Tribal Administrator (former Chairman), at 775/738-8889; called and left message there asking them to refer to fax of the April 26 letter
	<i>September 29, 2000</i>
	Advised by <b>Melanie Wong</b> to add <b>South Fork</b> to my list to contact; don't think I should call them; go through the Tribe
	Called <b>Roland McCook</b> at U&O, but they do not work on Friday; see below
	Spoke with <b>Charlotte Healey</b> , Wells Band Administrator, proved to be a wealth of information; October 23 is election day for the Tribe; she also gave me the names of the people below
	<b>Charlotte Healey</b> said that they would be interested in what happens at Skull Valley; liked the idea of meeting with them; suggested that meeting with the Te-Moak would be a good idea, when all the Bands are together; they meet the first Wednesday of the month; suggested to Charlotte that when they write back they should request a meeting
	Faxed <b>Charlotte Heally</b> the April 26, 2000 letter; 775/752-2179 fax; she will pass it on to <b>Nevada Penoli</b>
	<b>Claudette Ramos</b> Battle Mt. Band Administrator 775/635-8016 fax; don't think I should call her; go through the Tribe
	<b>Karen McDade</b> sits in the Council member for South Fork; 775/744-4523 fax; don't think I should call her; go through the Tribe
	Called <b>Melanie Wong</b> and advised on the above
	In the course of talking to <b>Ralph Pikyavit</b> 435/759-2400, Cultural Resources Coordinator for the Kanosh Band, he expressed interest in being kept abreast of what we are doing at Skull Valley; I guess that means a Consulting Party
	Called Te-Moak again; <b>Jennifer Saunders</b> was not in, but the receptionist directed me to <b>Helen Dave</b> 775/738-8145,

	the Tribe's Environmental Coordinator; faxed her the April 26 letter
	<b>Helen Dave</b> said that the Te-Moak Tribe was interested in the project and wanted to be kept abreast of things; also that I should direct all correspondence to the Tribe
	<b>Helen Dave</b> is interested in attending the meeting at Ibapah on Oct 23; all I could tell her was that it would be in the afternoon; called <b>Melanie Wong</b> and get details to relay to Helen; see 10/2/2000
	<i>October 3, 2000</i>
	Spoke with <b>Melanie Wong</b> and gave her details to relay to <b>Helen Dave</b> about the meeting in Ibapah; she is going to contact Helen about coming to Ibapah
	Called <b>Dave Allison</b> about talking with <b>Roland McCook</b> at U&O about whether or not they want to be involved; he said he will see him this afternoon
	Called <b>Chairperson Geneal Anderson</b> , Paiute Indian Tribe of Utah, Cedar City, or <b>Ms. Gayle Rollo</b> , Tribal Administrator; spoke with Gayle and she said to fax her the letter and she would bring it to Ms. Anderson's attention today
	<i>October 5, 2000</i>
	While speaking with <b>Gloria Benson</b> about another matter, mentioned that I had been trying to get in touch with <b>Chairperson Geneal Anderson</b> about the Skull Valley project; Gloria said that I should fax it to her right now as she was expecting a call from Ms. Anderson shortly
	Called <b>Melanie Wong</b> about the schedule so that a Paiute Tribal representative may attend one of the meetings in Ibapah or Wendover; left message; advised her of conversation with <b>Gloria Benson</b> and gave her the numbers for Gloria and <b>Gayle Rollo</b> ; Melanie also is going to call <b>Dave Allison</b> and inquire whether or not he asked <b>Roland McCook</b> about that Tribe's interest/involvement; see 10/13/2000
	<i>October 13, 2000</i>
	Conference call among the BIA folks involved with the EIS to go over the first set of comments
	During the conference call, asked <b>Dave Allison</b> if he has had a chance to ask Chairman <b>Roland McCook</b> about the Ute's participation as a consulting party; he has not had a chance to approach him with that question, but had heard through the grapevine that they would defer; tried to call Chairman McCook but they are all off on Friday
	Spoke with Chairperson <b>Geneal Anderson</b> from Paiute Indian Tribe of Utah and she and <b>Gloria Benson</b> have talked about this and they want to be involved in the sense they want to know what is going on; they have their next Tribal Council meeting on November 1; Chairman Anderson said that it would not be too late to get on the agenda; contact the secretary <b>Maureen Kietz</b> to get on the agenda; when Chairman Anderson is not in, the contact is <b>Gayle Rollo</b> and then <b>Gloria Benson</b>
	Called and left detailed message with <b>Melanie Wong</b> 301/415-6262 about the above
	Called <b>Paul Nickens</b> 520/577-6024; left message
	Called <b>Paul Young</b> at Elko and advised of upcoming trip; left message; sent Paul e-mail advising him of the schedule
