

The purpose of this modification is to:

1. Exercise option year one of the contract in accordance with Federal Acquisition Regulation Clause 52-217-9, entitled, "Option to Extend the Term of the Contract," and Contract Clause B.16, entitled, "Duration of Contract Period," thereby extending the contract period of performance through December 22, 2001. As a result of this action, the contract ceiling is hereby increased from \$143,750.00 by the total ceiling amount for option year one of \$114,100.00 to \$257,850.00. In addition, the obligated amount of the contract is increased by \$58,100.00 from \$87,750.00 to \$145,850.00.
2. Provide for an administrative change to revise Subsection B.4, entitled, "Supplies of Services and Prices/Costs."

Accordingly, the contract is hereby modified as follows:

- (1) Under Subsection B.4, Supplies of Services and Prices/Costs, the sentence "Firm Fixed Price Total Amount," is deleted in its entirety and replaced with the following:

"B.4.1 CONSIDERATION AND OBLIGATION -- REQUIREMENTS
(JUN 1988)

- a. The total estimated amount (ceiling) for the products/services, ordered, delivered and accepted under this contract is \$257,850.000. The Contracting Officer may unilaterally increase this amount as necessary during the contract period for orders to be placed with the contractor during the contract period provided such orders are within any maximum order limitation prescribed under this contract.
- b. The amount presently obligated with respect to this contract is \$145,850.00. The Contracting Officer issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

- (2) Subsection B.16, Duration of Contract Period is deleted in its entirety and substituted in lieu thereof the following:

"B.16 DURATION OF CONTRACT PERIOD

The ordering period for this contract shall commence on December 23, 2000, and will expire on December 22, 2001. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18). The term of this contract may be extended at the option of the Government for three (3) additional one-year periods."

- (3) By fax dated December 4, 2000, The Woodard Corporation waives the requirement for a 60-day preliminary notice of the Governments's intent to exercise the option period.

A summary of obligations for this contract, from date of award through the date of this action is provided below:

This modification obligates FY'01 funds in the amount of \$58,100.00

All other terms and conditions under this contract remains unchanged.
