Dear Ms. McGinty:

Pursuant to the Economy Act of 1932, as amended, the U.S. Nuclear Regulatory Commission (NRC) and the National Security Agency (DIRNSA) desire to enter into an agreement whereby DIRNSA will provide Secure Terminal Equipment (STE) and related STE warranty.

Accordingly, upon your agreement as provided below, the terms and conditions of this Interagency Agreement are as follows:

Article I - Scope of Work

DIRNSA will provide the STE equipment and warranty at the fixed government rates as follows:



