"(a) The total estimated cost to the Government for full performance of this contract is \$117,044.07, of which the sum of \$108,260.07 represents the estimated reimbursable costs, and of which \$8,784 represent the fixed fee."

"(c) The amount obligated by the Government with respect to this contract is \$117,044.07."
