

The purpose of this modification is to provide incremental funding in the amount of \$3,000. As a result of this action, the obligated amount is being increased by \$3,000 from \$20,562.50 to \$23,562.50.

Accordingly, the contract is hereby modified as follows:

Under Subsection B.2 - CONSIDERATION AND OBLIGATION-DELIVERY ORDERS, Paragraph (b), first sentence is hereby deleted in its entirety and substituted in lieu thereof the following:

“(b) The amount presently obligated with respect to this contract is \$23,562.50.”
