Dear Chairman Meserve:

I am writing to request that the Nuclear Regulatory Commission (NRC) immediately pause the recently resumed operations at the Indian Point 2 (IP2) nuclear facility in Buchanan, N.Y. pending the results of a thorough inspection of the plant and the development of oversight protocols designed specifically for the IP2 facility.

As you know, the radioactive leaks which forced IP2 to shut down last February created enormous anxiety and fear in the plant's surrounding areas. As you know, the facility is the first nuclear power plant in the country to be given a high risk "red flag" designation and the NRC's Office of the Inspector General has impugned the agency's inspection efforts, going as far as saying that it hastily approved a poorly performed 1997 inspection by Con Edison that "missed the vast majority" of the problems that led to the February shutdown.

The public's concerns were given new life this week when new leaks accompanied ConEd's prerestart testing. Despite these problems, ConEd proceeded with the restart during the early morning hours of January 3rd. In so doing, it provided local residents and officials with no advance notice of its plans and offered no assurances that further problems would not occur. I find it troubling that after close to a year of promises and efforts to ensure safety at IP2, the plant continues to be plagued with problems.

This latest incident at the facility coupled with IP2's troubling history make it necessary for both the NRC and ConEd to go the extra mile in restoring the public's trust and to ensure that the resumption of operations at IP2 will pose no threat to surrounding communities. To that end, I am asking that IP2 be closed until the NRC thoroughly inspects the facility's major components, operations and safety systems and develops a series of protocols tailored specifically for operations at the IP2 site. These protocols should include mandatory public briefings and a plan of follow-up inspections to be done by an independent panel which would be comprised of industry experts as well as local officials.

In the short-term, the NRC and ConEd should avail representatives to meet with local residents immediately to brief them on what has gone on at the plant this week. When it comes to the operation of a nuclear plant with a history of leaks and shut downs, the public's concerns must not just be pacified, they must be put to rest.
