The purposes of this modification is to: 1) exercise Option Period III hereby extending the contract period of performance through June 30, 2002, in Sections B.3 and B.5, and 2) revise Section B.8 to increase the ceiling amount by \$48,840, and provide incremental funding in the amount of \$48,500. Accordingly the following changes are hereby made:

1. As a result of exercising Option Period III, Section B.3(a), and B.5 are revised as follows:

"B.3 52.216-18 ORDERING

(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from July 1, 1998, through June 30, 2002."

"B.5 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 1 (JUN 1988)

The ordering period of this contract shall commence on July 1, 1998, and will expire June 30, 2002. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18, Ordering)"

2. Section B.8 is here revised to increase the estimated cost ceiling from \$147,000 by \$48,840 to \$195,840, as a result of exercising Option Period III. In addition, incremental funding is provided in the amount of \$48,500, thereby increasing the obligated amount from \$91,334 to \$139,834. Section B.8 is revised as follows:

"B.8 CONSIDERATION AND OBLIGATION

The total estimated cost ceiling to the government for full performance of this contract through Option period III is \$195,840. The amount obligated to date under this contract is \$139,834."

A summary of obligations to date is as follows:

Total Obligations: \$139,834

This modification obligates funds in the amount of \$48,500.

All other terms and conditions remain the same.
