This report transmits the results of the subject reactor operator initial licensing examination retake conducted by the NRC on November 13, 2000. The examination addressed areas important to public health and safety and was developed and administered using the guidelines of the "Examination Standards for Power Reactors" (NUREG-1021, Revision 8, Supplement 1). In accordance with the Examination Standards all previously passed portions of the examination were waived.

Based on the results, the Reactor Operator (RO) passed the Part "A" operating test of the examination. The preliminary performance insights observed during the examination were discussed between Mr. L. Briggs and Mr. M. Wilson on November 13, 2000. The final results were discussed via telephone on November 22, 2000. No findings were identified.

#### a. <u>Inspection Scope</u>

The RO applicant had successfully passing all portions of the initial examination, with the exception of Part "A" of the operating test, given the week of August 7, 2000. Those portions of the examination were waived in accordance with the Examination Standards. The NRC examiner reviewed the Part "A" operating test retake submitted by the Millstone Unit 2 training staff to verify or ensure, as applicable, the following:

- That the examination retake was prepared and developed in accordance with the guidelines of Revision 8 of NUREG-1021, "Operator Licensing Examination Standards for Power Reactors." The review was conducted in the Region I office. Final resolution of comments and incorporation of test revisions was conducted during the week of October 30, 2000.
- That the examination retake met the overall quality goals of NUREG-1021, Revision 8 (interim guidance is contained in Report of Interaction 99-18, dated November 24, 1999, and posted on the NRC's internet home page).
- That examination security requirements were met.

The NRC examiner administered the Part "A" operating test to the RO applicants on November 13, 2000.

b. <u>Findings</u>

#### Grading and Results

One RO applicant was examined and passed the administrative portion (Part "A") of the operating test.

# Examination Preparation and Quality

No inspection findings were identified.

# Examination Administration and Performance

There were no observations or findings made by the examiner.

On November 13, 2000, the NRC Chief Examiner discussed preliminary overall observations noted during the examination with the Manager, Operations Training.
