Pursuant to 10 CFR 50.54(p)(2), Northeast Nuclear Energy Company (NNECO) hereby submits Revision 40 to the Millstone Station Physical Security Plan (PSP). A description of the changes to the PSP are contained in Attachment 1. The revision to the PSP is provided as Enclosure 1.

The Millstone Nuclear Power Station Site Operations Review Committee has evaluated the revision pursuant to 10 CFR 50.54(p) and concurs that it does not decrease the effectiveness of the PSP. Pursuant to 10 CFR 73.21(b), the PSP is considered safeguards information and, as such, NNECO requests that Enclosure 1 be withheld from public disclosure pursuant to 10 CFR 2.790(d)(1). Upon separation of Enclosure 1, the remainder of this letter may be decontrolled.


