Dear Mr. Sinclair:

We have reviewed the Utah proposed regulation R313-19, Requirements of General Applicability to Licensing of Radioactive Material, as requested by your letter dated November 14, 2000. The proposed regulation is in response to the one amendment identified in the enclosed Regulations Assessment Tracking System (RATS) Data Sheet. The regulation was reviewed by comparison to the equivalent NRC regulations in 10 CFR Part 30. We also discussed our review of the regulation with Craig Jones on December 14, 2000.

As a result of our review, we have no comments. Please note that we have limited our review to regulations required for compatibility and/or health and safety. Under our current procedure, a finding that a State regulation meets the compatibility and health and safety categories of the equivalent NRC regulation may only be made based on a review of the final State regulation. However, we have determined that if your proposed regulation were adopted without significant changes, it would meet the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure SA-200.

We request that when the proposed regulation is adopted and published as a final regulation, a copy of the "as published" regulation be provided to us for review. As requested in STP Procedure SA-201, *Review of State Regulations*, November 10, 1998, please highlight the final changes and send one copy in a computer readable format, if possible.

We have also summarized on the RATS Data Sheet our knowledge of the status of other Utah regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the RATS Data Sheet.
