### BRUNSWICK STEAM ELECTRIC PLANT, UNIT NOS. 1 AND 2 DOCKET NOS. 50-325 AND 50-324 / LICENSE NOS. DPR-71 AND DPR-62 DECEMBER 2000 MONTHLY OPERATING REPORTS

Gentlemen:

In accordance with Technical Specification (TS) 5.6.4 for the Brunswick Steam Electric Plant (BSEP), Unit Nos. 1 and 2, Carolina Power & Light (CP&L) Company is submitting the enclosed Monthly Operating Reports for December 2000. These reports are being submitted to the NRC by the 15th day of the month following the calendar month covered by the reports, as specified in TS 5.6.4.

CP&L has determined that the Net Electrical Energy (MWH) value for BSEP, Unit 2, provided in the June 2000 monthly operating report submitted July 11, 2000 (Serial: BSEP 00-0096), is incorrect. The Net Electrical Energy (MWH) value for the month of June 2000 is actually 45 MWH less than was reported. This discrepancy is also reflected in the Year To Date and Cumulative values for Net Electrical Energy reported in the July 11, 2000, submittal, as well as subsequent monthly operating reports dated August 9, 2000 (Serial: BSEP 00-0116); September 13, 2000 (Serial: BSEP 00-0133); October 12, 2000 (Serial: BSEP 00-0146); November 7, 2000 (Serial: BSEP 00-0159); and December 11, 2000 (Serial: BSEP 00-0177). The Year To Date and Cumulative Net Electrical Energy values provided in Enclosures 1 and 2 of this letter have already been adjusted by 45 MWH to account for the discrepancy.
