The purpose of this modification is to (1) exercise Optional Task 3 under the subject contract, (2) revise Section B.3 to reflect the current obligations for the period of performance, (3) revise Section F.2 to add the deliverable dates for Task 3, (4) revise Section F.4 to extend the period of performance to cover Task 3, and (5) revise the project officer under the contract. Accordingly, the following changes are hereby made:

1. Section B.3, "CONSIDERATION AND OBLIGATION -- COST PLUS FIXED FEE (JUNE 1988), subparagraph (c), the following sentence is added:

"The amount obligated by the Government with respect to this contract is \$49,466.10 for Task 3."

2. Section F.2, "DELIVERABLES AND DELIVERY SCHEDULE, for Subparagraph (3)(a), add the due date of "fifteen (15) weeks after the award date of Optional Task 3" for the Draft Task 3 Deliverable. For Subparagraph (3)(b), add the due date of "twenty-two (22) weeks after the award date of Optional Task 3" for the Final Task 3 Deliverable.
3. Section F.4, "DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987), extend the ending date of the period of performance to "5/31/2001."
