The purpose of this modification is to (1) increase the contract ceiling amount by \$10,420 from \$929,393 to \$939,813 (corrects the ceiling amount from Modification No. 12 to include the total Option Year 2 costs), and (2) increase the total amount obligated by \$34,141 from \$905,672 to \$939,813 to cover the French portion of the work under the subject contract. Accordingly, the following changes are hereby made:

1. SECTION B.3, "CONSIDERATION AND OBLIGATION-COST REIMBURSEMENT (JUN 1988) ALTERNATE I, paragraphs a and c are revised to read as follows:

"a. The total estimated cost to the government for full performance under this contract is \$939,813. The amount of \$766,166 is for NRC work and the amount of \$173,647 is for the French portion of the work."

"c. The amount obligated by the government under this contract is \$939,813."
