The purpose of the modification is to: (1) exercise option year one of the contract in accordance with Clause 52-217-9, entitled, "Option to Extend the Term of the Contract," and Contract Clause B.16, entitled, "Duration of Contract Period," thereby extending the contract period of performance through March 13, 2002; (2) increase the contract ceiling amount in the contract by \$692,750 from \$692,750 to \$1,385,500; and (3) increase the obligated amount by \$250,000 from \$300,000 to \$550,000. Accordingly, the contract is hereby modified as follows:

•

1. Under Subsection F.4 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988) the paragraph under this subsection is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"The ordering period for this contract shall commence on March 13, 2000, and will expire on March 12, 2002. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the option of the Government for an additional 2 years."

- 2. Under Subsection B.4 CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988), the first sentences in paragraphs (a) and (b) are deleted in their entirety and the following are substituted in lieu therefore:
 - "(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$1,3385,500."
 - (b) The amount presently obligated with respect to this contract is \$550,000."

All other terms and conditions of this contract remain unchanged.

A summary of obligations for this contract from award date through the date of this action is given below:

TOTAL FY00 OBLIGATIONS:	\$300,000
TOTAL FY01 OBLIGATIONS:	\$250,000
CUMULATIVE TOTAL OF NRC OBLIGATIONS:	\$550,000

This modification obligates FY01 funds in the amount of \$250,000.
