SUBJECT: INTERAGENCY AGREEMENT NO. NRC-03-01-001, ENTITLED, "REVIEW OF HYDRODYNAMIC LOADS ON EMERGENCY CORE COOLING SUCTION STRAINERS"

Pursuant to the Economy Act of 1932, the U.S. Nuclear Regulatory Commission (NRC) desires to enter into an agreement with the U.S. Department of the Navy, Naval Postgraduate School (NPS), whereby the NPS will provide technical assistance to the NRC's Office of Nuclear Reactor Regulation, Division of Systems Safety and Analysis, in the review of documentation relating to hydrodynamic loads on submerged structures. The NPS shall also provide expert opinions of the validity of the correction factor for the Keulegan-Carpenter number developed by Bliss and Franzoni, in accordance with the enclosed Statement of Work (SOW) (Enclosure No. 1).

SCHEDULE OF PRICING

The NPS will provide technical assistance to NRR's DSSA, at a total estimated cost not to exceed \$50,000.00.

PERIOD OF PERFORMANCE

The period of performance of this agreement will be January 1, 2001 to December 31, 2001.

PAYMENT BY THE NRC TO NPS

If possible, the NPS shall bill the NRC for costs incurred through the Treasury On-line Payment and Collection (OPAC) System. All payments to the NPS will be transmitted electronically in accordance with FAR Clause 52.232-28, Electronic Funds Transfer.
