SUBJECT: Executive Order 13160 Guidance Document

As you know, on June 23, 2000, the President issued Executive Order 13160, entitled "Nondiscrimination on the Basis of Race, Sex, Color, National Origin, Disability, Religion, Age, Sexual Orientation, and Status as a Parent in Federally Conducted Education and Training Programs." As required under this Executive Order, the Department of Justice has developed a Guidance Document to assist all federal agencies in complying with these important equal opportunity mandates.

We are pleased to advise you that this Guidance Document, entitled "Ensuring Equal Opportunity in Federally Conducted Education and Training Programs," will be published in Part XIV of the Federal Register on January 18, 2001. This Guidance Document addresses a number of issues including the scope of covered programs, applicable legal principles, examples of discriminatory conduct, enforcement procedures, remedies, and reporting requirements for federal agencies. We hope that this Guidance Document will be helpful to you in implementing Executive Order 13160.

In addition, we would like to take this opportunity to remind you that, in order to comply with Executive Order 13160, each federal agency must establish procedures for receiving and addressing complaints within 90 days of publication of the Attorney General's Guidance Document. Recommendations for establishing such complaint procedures are outlined in the Guidance Document. The Guidance Document also addresses other agency obligations, including the development of appropriate outreach materials and agency reporting requirements.
