(BILLIE W. CHILDERS, JR. v. CAROLINA POWER AND LIGHT COMPANY)

Dear Mr. Keenan:

On October 21, 1996, the NRC's Office of Investigation (OI) initiated an investigation to determine if Billie W. Childers, Jr. was subjected to illegal discrimination by Carolina Power and Light Company (CP&L) management while employed at the Brunswick Steam Electric Plant. The OI investigation, documented in OI Report No. 2-1996-041, concluded that the evidence developed did not substantiate that Mr. Childers was subjected to illegal discrimination. By letter dated July 31, 2000, you were provided a copy of the OI report synopsis, and informed that the NRC would hold final judgement in the case pending completion of DOL activities.

As background, on January 29, 1998, a U.S. Department of Labor (DOL) Administrative Law Judge (ALJ) issued a Recommended Decision and Order regarding a similar complaint of discrimination filed by Mr. Childers. The ALJ found that the evidence showed that CP&L had legitimate, non-discriminatory reasons for actions taken against Mr. Childers. Based on this, the ALJ dismissed the complaint. This case was subsequently appealed to the DOL Administrative Review Board (ARB Case No. 98-077). On December 29, 2000, the ARB issued a Final Decision and Order dismissing the case on its merits.
