Dear Mr. Tanner:

I am responding to your November 5, 1997, letter, in which you request that I place your organization on a mailing list to receive notices of public meetings and other licensing actions associated with the application filed by Private Fuel Storage, L.L.C. (Docket 72-22) to construct and operate an Independent Spent Fuel Storage Application on the Skull Valley Goshute Reservation. Generally, only parties to a particular license application are placed on the service list. I believe, however, that existing public notification processes provide you with sufficient avenues to gather the information you have requested. All non-proprietary correspondence related to the Private Fuel Storage, L.L.C. license application is publicly available at the Nuclear Regulatory Commission's Public Document Room (PDR) located at 2120 L Street, NW, Washington, DC 20003-1527 and at the Local Public Document Room that will be opening soon at the Marriott Library at the University of Utah in Salt Lake City, Utah. For a fee, the PDR will provide copies of requested information to you. All public meetings are listed on NRC's Internet website (<http://www.nrc.gov>). The list can also be accessed by calling (toll free) 1-800-952-9674. All licensing actions (e.g., docketing, granting a license, Director's Decisions pursuant to 10 CFR 2.206) are noticed in the Federal Register.

To assist you in using the PDR, I have enclosed a copy of the "Public Document Room User's Guide," NUREG/BR-0004.

I trust that this responds to your request.
