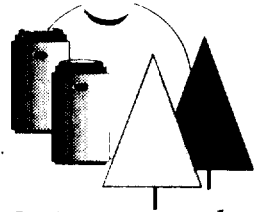

The final response to the NRC Request for Additional Information (Reference 1) was scheduled for submission to the NRC by December 15, 1998, as noted in Reference 2. As discussed with Mr. Mark Delligatti, NRC Senior Project Manager, over the past several weeks, Private Fuel Storage (PFS) will require additional time to complete the response to RAI questions 2-5 and 2-7. Additional data collection activities, field conditions, and equipment problems have all played a role in this delay and have been unavoidable. All field activities needed to respond to RAI questions 2-5 and 2-7 have been completed as of November 14, 1998. Data analysis is in the final stages of completion and response preparation activities are underway.
