I am enclosing a copy of the Scoping Report (SR) prepared as part of the Environmental Impact Statement (EIS) scoping process, in connection with your June 20, 1997, application for a license to construct and operate an independent spent fuel storage installation (ISFSI) located on the Skull Valley Indian Reservation in Toole County, Utah.

The scoping process for this EIS was conducted in accordance with 10 CFR Part 51, which contains the Nuclear Regulatory Commission's (NRC's) requirements for implementing the National Environmental Policy Act. The scoping process included a public scoping meeting held June 2, 1998, at the Little America Inn, Salt Lake City, Utah. In addition to the public scoping meeting, NRC invited interested agencies, organizations, and individuals to submit written suggestions and comments for consideration in the scoping process. The enclosed EIS SR includes consideration of comments made at the public scoping meeting and those submitted in writing.

We will transmit to you at a later date a list of questions and requests for information that are based on our environmental review, including, as appropriate, comments received in the scoping process.
