On January 23, 2001, a public meeting was held between representatives of the U.S. Nuclear Regulatory Commission (NRC) and the Nuclear Energy Institute (NEI) to discuss the spent fuel storage cask Standard Technical Specifications (STS) effort that both organizations have been developing. The meeting was noticed on January 10, 2001.

Following introductory remarks by NRC and NEI representatives, Chris Jackson and Carl Withee (NRC) provided an overview of the STS effort (see Attachment 1). In the general discussion that followed, NEI and industry representatives raised a number of questions and issues about the draft STS document issued on December 21, 2000. NRC staff clarified some issues and agreed to further consideration of others. NEI committed to providing, by February 23, 2001, consolidated industry comments to the staff on the draft STS document. It was agreed that further discussions would be held on this topic.
