 July 1, 2000 THROUGH December 31, 2000**

During the second performance period of 2000, the STP Nuclear Operating Company (STPNOC) Fitness for Duty (FFD) Program conducted a total of 584 FFD screening tests that resulted in three positive test results. The positives were comprised of short-term contractors of which all were pre-access.

STPNOC Quality Assurance Department audited the FFD Program during this performance period. The audit identified one minor deficiency that was documented through the used of the station's Corrective Action Program. Condition Report (CR) 00-14074 noted that FFD's quality records were not being transmitted to Records Management in a timely manner. Records are currently transmitted to Records Management per procedural requirements.

STPNOC did not have any 10CFR26.73 reportable events during the performance period.
