Dear Mr. Snellings:

As requested, we have reviewed the proposed regulations in the Arkansas Department of Health's Draft Revisions to the Rules and Regulations for Control of Sources of Ionizing Radiation, sent on October 31, 2000. The proposed regulations evaluated are in response to the 17 amendments identified in the enclosed Regulations Assessment Tracking System (RATS) Data Sheet. The proposed regulations were reviewed by comparison to the equivalent NRC regulations in 10 CFR Parts 19, 20, 30, 32, 34, 35, 36, 39, 61, 71, 150 and Part T of the Suggested State Regulations dated February 1999. We also discussed our review of the regulations with Mr. Bernard Bevill on December 12, 2000 and January 2-4, 2001.

As a result of our review we have 11 comments that have been identified in the enclosure. Please note that we have limited our review to regulations required for compatibility and/or health and safety. Under our current procedure, a finding that a State regulation meets the compatibility and health and safety categories of the equivalent NRC regulation may only be made based on a review of the final State regulation. However, we have determined that if your proposed regulations were adopted incorporating the comments and without other significant change, they would meet the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure SA-200.

We request that when the proposed regulations are adopted and published as final regulations, a copy of the "as published" regulations be provided to us for review. As requested in STP Procedure SA-201, Review of State Regulations (November 10, 1998), please highlight the final changes and send one copy in a computer readable format, if possible.

We have also summarized on the RATS Data Sheet our knowledge of the status of other Arkansas regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the RATS Data Sheet.
