Page 2.3-48 -- How did the dimensions of the natural draft cooling tower shrink from previous values?

Chapter 6

Page 6.3-7 -- What led to the 100% clogged assumption (from 50%) for suppression pool suction strainers? Design change? New analysis? New requirement?

Chapter 7

Pages 7.2-4, 7.6-20 -- New text added to describe the Oscillation Power Range Monitor (OPRM). Since implementation of the OPRM is an approved design basis change via a Technical Specifications amendment, I believe it would be a good idea for Niagara to, in the future, reference the NRC approval document (i.e., Amendment No. 92 dated March 2, 2000).

Chapter 9

Pages 9A.3-29, 29a -- What was the reason for now adding this paragraph regarding surveillance intervals? New requirement? Or was the description inadvertently omitted in the previous revisions?

Chapter 11

Table 11.1-6, regarding noncoolant activation products: what changes have been made?

Chapter 12

Table 12.2-6, regarding reactor core isolation cooling system design activities. What let to the extensive changes in this table? Fine-tuning of a previous calculation? Correction of previous error?

Chapter 15

Page 15.2-2, Section 15.2.1.2.3 -- Does the word "interim" mean that something (e.g. evaluation model) is still under development, to be finalized in the future?

Appendix A, Reload Analysis

Page A.4.4-1 -- ORPM. For the sake of completeness of documentation, it would be good to reference NRC approval documents in the UFSAR. Please consider this suggestion for future revisions.
