Dear Sir or Madam:

The purpose of this letter is to notify the Nuclear Regulatory Commission ("NRC") of the change in ownership of the Trus Joist MacMillan ("TJM") facility located at 100 TJM Drive, Buckhannon, West Virginia 26201 (the "Facility"). Effective January 31, 2001, Weyerhaeuser Company ("Weyerhaeuser") will be the legal owner/operator of the Facility. Two nuclear devices under the General License of 10 C.F.R. § 30.5 will remain in use at the Facility. Although the ownership of the Facility is changing, there will be no change in the location or the use of the devices.

Pursuant to 10 C.F.R. § 31.5(c)(9) and based on a conversation with John Pelchat at NRC Region II, TJM is providing NRC with the following information. The first device was manufactured by Ohmart Corporation and is identified as (1- 50 mCi, Cs-137 (A – 2102) in SH-F1 (W-4000 – belt scale)). The serial number for the device is 6705GK. The second device was also manufactured by Ohmart Corporation and is identified as (1/W-4200 Weight Scale with total 40 mCi Cesium-137 (Ohmart Sealed Source A – 2102) in one Ohmart SHRM-BW Source holder). The serial numbers for this device are 5077GK and 5779GK. January 19, 2001 Page 2

Trus Joist requests that the NRC adjust its records to reflect the following information. As indicated above, the transferee is Weyerhaeuser. Weyerhaeuser's address is: P.O. Curtis Rhodes, the environmental coordinator for the Facility, is the Facility contact person and can be reached at (304) 472-8564. All correspondence related to the General Licenses should be forwarded to Mr. Rhodes at the Facility address as set forth above in paragraph number one.

As required by 10 C.F.R. § 31.5(c)(9), TJM has provided Weyerhaeuser a copy of 10 C.F.R. § 31.5 and safety documents identified in the label of the devices. For your information, Weyerhaeuser has notified the Ohmart Corporation of the change in ownership of the Facility.
