## Financial Assurance Evaluation Calendar Year 2000

The Region I Financial Assurance Instrument Security Program was compared with the guidelines of Management Directive 8.12. Overall, the program meets the key guidelines of the MD 8.12 Handbook with the following exceptions. Comments are listed in order of program significance.

1. E(2)(b). Evaluation of the Decommissioning Financial Assurance Inventory.

Comment. All files on the Inventory list were reviewed against the guidelines identified in Section E (2)( b) of the MD 8.12 Handbook. When compared with previous evaluations, many files were upgraded and found complete. However, for all files to meet the Handbook guidelines, additional improvements are necessary as noted in Attachment 2.

2. C(1)(a)(vi). The inventory list of financial assurance instruments held in the safe must include the expiration date.

Comment. The inventory list will be revised to include expiration date.

3. B(5). License file copies will be stamped "nonnegotiable" and the identification number of the instrument will be blacked out.

Comment. A random sample of 13 docket room license files (PA-7, CT-3, NJ-3) maintained for licensees requiring financial assurance indicated that all instrument copies were not marked as required.

4. E(4). An external evaluation shall be performed of the Regional program by the Division of Waste Management every two years through IMPEP.

Comment. The last external evaluation was performed during the 1998 IMPEP review. An external evaluation appears appropriate whenever a Regional IMPEP review is performed instead of the prescribed two year frequency. An IMPEP is scheduled for March 2001, and the inconsistency should be discussed.
